

Data Protection Declaration

General provisions

This data protection declaration lays down rules relating to the kind, scope and purpose of elicitation and application of personal data by the maintainer of the website – PKM electronic GmbH, Ohmstrasse 1, D-84130 Frontenhausen, e-mail: via contact form.

Definitions of the used terms you can find in Art. 4 General Data Protection Regulation (GDPR).

Access data

The maintainer of the website takes your data protection very seriously und keeps your personal data in confidence conforming legal regulations. By new technology and continuous development of this website it may be necessary to make changes to this data protection declaration steadily.

For the purposes of legitimate interests (Art. 6 par. 1 point f. GDPR) we, the maintainer of this website, collect access data to the website and put them as “server-logfiles” on server of the website. Following data are recorded:

- visited website
- time of access
- quantity of sent data in byte
- originator, from which you gained access to the side
- used browser
- used operating system
- used IP-address

Server logfiles are stored up to 8 weeks and subsequently erased. For reasons of safety we store the data, e.g. to clear up malpractices. If data have to be stored for arguments the erasure of these data cannot take place as long the incident is not finally clarified.

Cookies

This website uses no cookies.

Recording and processing of personal data

The maintainer of the website collects, uses and transfers your personal data only if it is permitted by law or you have explicitly consented to the proposed transfer (in case of transfer to a third country or an international organization you are to be previously informed of the possible risks of such transfers due to the absence of an adequacy decision and appropriate safeguard).

For the purposes of the General Data Protection Regulation (GDPR) ‘personal data’ means any information relating to an identified or identifiable natural person (‘data subject’). An identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person.

You can visit this website without giving your personal details. However, to improve our online-offer we save your access data without any personal references just as your requested file or the name of your internet provider. Due to the anonymization of data it is not possible to draw conclusions about you.

We process personal data such as IP address, first name, last name, e-mail address and message on our contact form only when the data object has explicitly consented to the processing and in accordance with data protection regulations, if it is necessary for the performance of a contract between the data subject and PKM electronic GmbH or the implementation of pre-contractual measures taken at the data subject's request.

Handling of Contact Details

If you contact us by offered contact opportunities we store your information to process and reply your request. Without your consent we will not transfer your contact details to third parties.

Handling of Messages and Comments

Do you write a message or comment on the contact form we store your IP address for the purposes of the legitimate interests by PKM electronic GmbH pursuant to Art. 6 par.1 point f. GDPR in case your message or comment breaks the law.

Rights of the data project

The data project shall have following rights:

- Right of access by the data subject (pursuant to Art. 15 GDPR)
- Right to rectification (pursuant to Art. 16 GDPR)
- Right to erasure (pursuant to Art. 17 GDPR)
- Right to restriction of processing (pursuant to Art. 18 GDPR)
- Right to data portability (pursuant to Art. 20 GDPR)
- Right to object (pursuant to Art. 21 GDPR)
- Right to not solely automated individual decision-making, including profiling (pursuant to Art. 22 GDPR)

Erasure of personal data

Personal data stored by us, no longer required for the purpose and no statutory retention period, will be erased. If an erasure cannot be performed because of permitted legal purposes, data will be used restrictedly. In this case data will be locked and not processed.
